Usual Business

- 1. Secretary's Report (Sara). Presentation of April 12, 2023 Minutes; Susan moved to accept the minutes as presented; Bill seconded
- Treasurer's Report (via email): Treasurer's report and budget analysis (see budget handout). Expenditures and accounts reviewed with discussion of use of funds from the food trucks and discussion of the theft of the large food truck sign which had been placed in the median. Sara moved to accept the report and analysis; Susan seconded
- 3. Crime Report (Tony; handout); A slight increase in crimes is reported with consistent reporting of same types of crimes.
- 4. Website (Tony): No new updates
- 5. Newsletter April minutes have been forwarded to John

Old Business

- 6. Netherwood Park Bites Food Truck Nites: food trucks started May 3 with good attendance at the opening night. Trucks were canceled May 10 because of wind. New yellow banner replacing vandalized one was hung on NPNA Indian School sign advertising Bites Nites prior to the initial food truck night but was subsequently stolen from the median before the opening night. A police report has been filed and discussion about replacing the banner a third time is ongoing.
- 7. Memorial to Chuck Maguire: Bench and plaque should be available to be installed within the next few months. A brief discussion was made regarding the presentation of the donation to TCA from the memorial donations collected. This donation will go to help fund youth tennis. Further discussion will be held at the next meeting but members present agreed a card, roses, and a check would be a good approach.

- 8. Neighborhood Watch progress: areas still needing captains. More progress likely as the weather improves
- 9. Former K-Mart / Whole Food site: progress on Whole Foods buildout proceeding. American Furniture to move to that area also. Burger King is now open. Whole Foods and American Furniture to be open by the end of 2023.
- 10. Urban Forest Guardians report: Urban Forest has remained free of campers and other homeless encampments over the last few weeks. Neighbors actively involved in patrolling the area.

NEW BUSINESS

- Discussion continues regarding the slowing of traffic on Indian School. The board will arrange a meeting with counselor Fiebelkorn to discuss setting up a traffic study and to discuss the 2018 plan and its approval. Additional changes to this plan have been proposed and whether these can be added to the original approval needs to be clarified. As mentioned at the previous board meeting in April, initial steps to be taken from this point on the board agrees that:
 - 1. Confirmation that 2018 plan has indeed been approved needs to be made. Will need to contact Councilor Fiebelkorn or her assistant Laura Rummler for this confirmation.
 - 2. Once confirmation of 2018 plan approval is obtained, Netherwood park neighbors will need to be informed.
 - 3. Proceed with updated traffic study and recommend implementing some of the road calming measures listed above (pedestrian-activated crosswalks, radar speed sign, etc).
 - 4. Capital outlay funding would then need to be obtained to implement any larger plan (already approved plan or a proposed plan).

As information on these issues is obtained, Netherwood Park neighbors will be informed.

- 2. NPNA Board info: One spot on the board has been open. Meghan Eastep was invited to attend the meeting by Susan and she expressed interest in joining the board. Susan nominated Meghan for membership on the board and Zephyr seconded the nomination. All members present physically and remotely voted to appoint Meghan to the board.
- 3. Bylaws committee: the committee chaired by Susan to modify the bylaws will hold a meeting on May 19. Chris, Meghan and Sara will assist; any other members of the board are welcome.
- 4. Ana Maria will be absent from the neighborhood for an undetermined period of time due to family health reasons. Her position on the board will be reserved for her return and we await updates.
- 5. The Earth Day cleanup was held April 22 with neighbors cleaned the Urban Forest Park area as well and the Indian School corridor.

Zephyr moved to close the meeting at 5:07 with Susan seconding, The meeting was adjourned at 5:07. Next board meeting to be held June 14 at 4:00 at TCA.
